PL/2025/04201 Notification of proposed works to trees in a conservation area - Willow tree - Pollard to 4-5m Four Lawson Cypress trees - Fell at ROSE COTTAGE, GREENGATE ROAD, WEDHAMPTON, DEVIZES, SN10 3QB - PM had photographed the trees for the benefit of all councillors, PM stated that they are not overlooked and had no impact on neighbouring properties. The trees brought no benefit to the community.

PL/2025/03531 Full planning permission - Full Planning Application for the Erection of a Self-build Rural worker's dwelling and associated infrastructure at GOOSEHOLE FARM, URCHFONT, DEVIZES, SN10 4RJ Goosehole Farm, Urchfont, Devizes, SN10 4RJ - A few councillors visited the site. Very comprehensive plans produced along with business plan indicating the intension of building a calf rearing facility with an essential resident farm worker. A long-term tenant is currently in the current farmhouse, hence the need to build the additional accommodation and infrastructure. JW had established that there would be no objections from statutory officers. AS reiterated the very comprehensive nature of the business plan and was of the opinion that such a farm worked would not be able to afford accommodation in Urchfont. AS commented that the case had been put together very well.

PL/2025/03334 - Full planning permission - Proposed replacement house (Self Build / Custom Build) and associated parking and landscaping at Wayside Cottage, Cuckoo Corner, Urchfont, Devizes, SN10 4RA – several councillors visited the site earlier in the week. JW noted that there had only been one house previously, the suggestion that more properties should be built on this site is not the subject of this application. JW expressed concerns about the height of the three storey proposal, she is not in favour. AS did not agree, the site is lower than the next

property and the property will be 24 metres from that next property. If this application is not approved, then we are likely have the current derelict property for the future. PM said that she agreed and supports the application because the current property is an eyesore, surrounding trees are on adjacent properties. JR stated that 3 storey's is not the issue, the overall height of the house could be. The applicant was asked to comment, he stated that the building is likely to be lower than the adjacent Somerton House.

PL/2025/03881 - Notification of proposed works to trees in a conservation area - Sycamore (T1) - fell to 2/3m in height to leave habitat stem. Low fork in tree and it's growing into adjacent pine trees. Beech (T2) - reduce crown by 2m and shape. To be retained as a hedge trimmed tree at SOMERTON HOUSE, CUCKOO CORNER, URCHFONT, DEVIZES, SN10 4RA — TH and JW visited the site. A couple of the trees are very large; the sycamore has split and will be taken down to a level to form a wildlife station.

Patches of dead appearing where contractors have cut back too hard in the past. the hedge has outgrown the site and can't be reduced back any more without risk of dieback. Remove to ground level in Autumn when all nesting has finished and replace with native Beech or Hornbeam hedge this coming winter at LITTLE OAKFRITH, 6 PEPPERCOMBE CLOSE, URCHFONT, DEVIZES, SN10 4QS
