Currently a small building / car port. AS commented that alterations will facilitate changes to the main property to allow elderly relatives easier access / space. One set of panels will be on the main building and one on the garage and basically not widely visible or impacting neighbouring properties.

PL/2025/03173 - Householder planning permission - Side Extension to replace attached garage at 7 THE ORCHARD, URCHFONT, DEVIZES, SN10 4QX – JW and AS visited on Monday this week and met the applicant. The proposed extension to become a utility room will look a lot nicer than now. It includes solar panels which were indicated on the plans but not documented in the application, WC planning are OK with this and will take into account. AS could see no issues with separating the two adjoining garages which will both be made good as part of the requirement, neighbours have been consulted and are in full agreement. RH commented that WC Planning will no doubt ensure structural integrity of the two separated garages.

PL/2025/01229 - Proposed Works to Trees in a Conservation Area - Purple leaf plum (T1) - Reduce crown by 1-2m, crown clean and crown raise over the road to 5.2m. Norway maple (T2) - Reduce crown by 3-4m to below powerline, crown clean and crown raise over the road to 5.2m Ornamental crab apple (T3) - cut back/reduce limbs to clear phone and powerlines. Western red cedar and self-seeded holly (T4) - dismantle western red cedar to ground level as close to property and heavily leaning limb over road. Fell holly. Holly (T5) - on bank. Fell to ground level and replant bank with hazel. Purple leaf plum (T6) - fell to ground level and replant with a suitable replacement tree at FRIARS COTTAGE, HIGH STREET, URCHFONT, DEVIZES, SN10 4QL - NO OBJECTIO

7. Matters for Report

PL/2023/02372 - Land South of Ballingers - Appeal Decision

The appeal is allowed, and planning permission is granted for an outline application with all matters reserved bar access for the development of up to 21 dwellings, including affordable housing, 4 self-build plots and associated infrastructure at Land South of Ballingers, Urchfont, Wiltshire in accordance with the terms of the application.
